

Manager, Public Institute Sport and Youth Centre Piran, to ensure personal safety of people and property, and public order at the Portorož Sailing Centre (hereinafter JCP) issues:

HOUSE RULES OF THE PORTOROŽ SAILING CENTRE

1. All users and visitors are obliged to respect and adhere to the house rules of the JCP.
2. The Supervisory and Maintenance Service ŠIMC (hereinafter: NVS) keeps a log of users, activities, events, and damages. It regularly informs the Manager.
3. The whole JCP facility is under video surveillance.
4. The opening hours of the JCP facility are every day from 6:00 to 22:00.
5. The Piran Sports and Youth Centre does not take any responsibility for vessels, car trailers, and other sports equipment left by users on the JCP facility.

I. USE OF THE EXTERNAL PLATEAU

6. The main car and delivery of vessels entrance is through the sliding door from the main road. NVS is responsible for opening and closing the sliding doors.
7. Entrance to the parking lot by car is only allowed to JCP users during JCP's opening hours.
8. Use of the external plateau is permitted only prior agreement with the NVS; it is necessary to sign the JCP Use Agreement before each use.
9. Any activity on the external plateau should first be announced to the NVS, Tel. No. 041 925 351, between 8:00 and 12:00, at least 24 hours before the intended use.
10. Combined vehicles and vessel trailers shall be parked at a designated place on the platform.
11. Disposal of vessels, trailers, vehicles, and any other objects is strictly forbidden on the accessible path and the manipulative plateau.
12. The main pedestrian access to the JCP is through the doors located between the JCP and JK Pirate facilities, other accesses are unlocked as needed and in agreement with the NVS.
13. Disposal of waste oil, oil, and other oily products and detergents is strictly forbidden. These need to be taken to specific repositories.
14. Minors are only allowed to enter the JCP facility accompanied by an adult, sports associations that organize activities are responsible for minors who are involved in programs organized by them.

II. USE OF JCP's SERVICE SPACES (wardrobes, toilets, office, and multipurpose area)

1. Entrance to the facility and use of toilets is free for all visitors and users of JCP.
2. Entry to wardrobes and multi-purpose area is enabled according to the schedule of activities.
3. For safety purposes, changing rooms should be locked during offshore training.
4. The organizer of the regatta is obliged to inform the NVS of all irregularities and possible damages that occurred during the use of the JCP.
5. The user (organizer, company) that used the JCP when potential damage occurred is responsible for potential damage or destruction of the facility and equipment and is obligated to pay for the repair or replacement costs.
6. Upon finished use of the JCP, the organizer stores sports equipment and checks the changing rooms and a hangar where the sports equipment is stored, as well as all other rooms that were used.
7. No one is allowed to enter other premises of the JCP facility unless this is agreed with the NVS.
8. The schedules is coordinated by the Public Institute Sport and Youth Centre Piran.
9. The use of JCP and equipment is at your own risk.

III. USE OF HANGAR

1. The hangar may only be used by sports associations in accordance with the JCP Use Agreement.
2. Other users must not enter and use Hangar 1 in any way.
